**REQUEST FOR EXPRESS OF INTEREST**  
**NATIONAL TECHNICAL ASSISTANCE TO SUPPORT LABORATORY MANAGEMENT AND**  
**SOP DEVELOPMENT FOR COMPONENT 3.1, REFERENCE NO. ICS-036**

The Ministry of Public Works and Transport (MPWT); Ministry of Agriculture and Forestry (MAF); Ministry of Industry and Commerce (MOIC); Ministry of Public Security (MOPS); Ministry of Planning and Investment (MPI), Ministry of Health (MOH) and Ministry of Finance (MOF) of Lao PDR have received financing support from the World Bank's (WB) International Development Association (IDA) to implement the Southeast Asia Regional Economic Corridor and Connectivity (SEARECC) with a project duration of six (6) years starting from 4th quarter of year 2022. SEARECC consists of five (5) components as follow : (1) Lao PDR and Regional Connectivity Enhancement, (2) Logistics Services Development and Vorder-Crossing Management, (3) Strengthening Institutional Capacity and Regulatory Framework in Agriculture, Transport, and Investment Planning, (4) Project Management and (5) Contingency Emergency Response.

The Department of Planning and Finance (DPF) of the MPWT intends to engage a part-time suitably qualified and experienced National Consultant to support the Department of Agriculture (DOA), the Department of Livestock and Fisheries (DLF) and the Agri-Tech Laboratory (ATC) of the MAF, the Food and Drug Department (FDD) of MOH, as well as the International Laboratory Management Specialist hired by SEARECC in conducting the gap assessment and implementation of laboratory upgrades of the regional laboratory at Northern Agri-Tech Center and mini-labs at International Border Check Points and accreditation of selected lab by the counterpart authorities of China, Vietnam and Thailand. During the implementation of this assignment, the consultant shall carry out all activities in accordance with relevant project documentation, MAF regulations, and Lao legislation, including those related to environmental and social safeguard measures, and must ensure that all activities are in compliance with the requirements of the World Bank Environmental and Social Framework (ESF) and Environmental Health and Safety Guidelines.

This shall be a part-time assignment with estimated time input 60 person-days to be worked within 18-month consultancy service period. The assignment is planned to start in May 2023. The SEARECC Project now invites eligible individual consultants to indicate their interest in providing the Services. Interested Consultant should provide information (CV, Expression of Interest, other supporting information, if any) demonstrating that s/he has the required qualifications and relevant experience to perform the Services. In order to qualify for this position, the candidates shall meet the following experience and competence requirements:

- Master of Science or above in Agriculture science, Plant science, Microbiology or related discipline.

- At least 10 years of experience in working in the field of Agriculture especially, in phytosanitary laboratories.
- A similar assignment successfully completed within a period of the past 5 years, especially under a project financed by IFI is a strong asset.
- Working experience with development projects in Laboratory in Lao PDR will be a good advantage.
- Experience in using LC-MS-MS; GC-ECD-FPD and UHPLC-DAD will be a good advantage.
- Fluency in English, Thai and Lao language.
- Good knowledge of use of computer with full command of MS Office.
- Proven good coordination, reporting and communication skills
- Willingness to travel to project provinces as needed.
