5. A complete set of bidding document in English may be obtained free of charge by interested eligible bidders upon the submission of a written application to the address below.
6. Bids must be delivered to the address below on or before **14:00 h of 18 November 2025**. Electronic Bidding will not be permitted. Late Bids will be rejected. Bids will be publicly opened in the presence of the Bidders' designated representatives and anyone who chooses to attend at the address below on **14:00 h of 18 November 2025**.
7. All Bids must be accompanied by a Bid-Securing Declaration as per form provided in the bidding document.
