- 1. Bidding will be conducted in accordance with the Procurement Regulations for ADB Borrowers (2017, paras 2.10 to 2.13) using the Request for Quotation (RFO) method for Quotations.
- 2. Participation is open to all eligible firms from ADB Member countries.
- 3. To be qualified, you must demonstrate experience as a Service Provider of professional audit services by submitting at least three (3) audit contracts of similar size and nature funded by ADB or similar donor-funded projects in the past 5 years and a copy of a recent audit report (confidential information may be redacted). Bidders are in addition required to submit a valid business license and evidence of recent company tax payment. Sub-contracting of audit services is not permitted.

- 5. Your completed Form of Quotation including the required price schedule with authorized signatures, should be submitted before **14:00 hrs. on 22/12/2025** sealed in one envelope, (one original, one copy), addressed to and physically delivered to the PMU address. Quotations should be valid for a period of at least 90 days. Submissions lacking signatures, unsealed documents and late submissions will be rejected.
