The Lao People's Democratic Republic has received financing from the World Bank toward the cost of Southeast Asia Regional Economic Corridor and Connectivity Project (SEARECC), and intends to a part of the proceeds toward payments under the contract for Supply of Border Clearance Equipment for Pang Hoc and Nam Ngeun Checkpoints.
