Package QHCP-W06: "Civil Works Salavan/Champasak"

To Interested Bidders:

1. The Lao People's Democratic Republic has received financing from the Asian Development Bank toward the cost of the **Improving the Quality of Health Care Project** and intends to apply part of the proceeds toward payments under the contract for 'Civil Works Salavan/Champasak'.
2. The Ministry of Health now invites sealed bids from eligible bidders for the above civil works package. The construction works are to be implemented, starting tentatively in October 2026.
3. The Package consists of two lots:

Lot 1 Salavan Estimated value \$0.9 million	LaoNgam District Hospital, upgrade
Lot 2 Champasak Estimated value \$1.6 million	Pakse Health Science College, upgrade Pakxong District Hospital, upgrade Moulapamok District Hospital, upgrade

4. Bidders may bid for one or both contracts, as further defined in the bidding document. Bidders wishing to offer discounts in case they are awarded more than one contract, or for individual lots, will be allowed to do so, provided those discounts are included in the Letter of Bid with the method for applying them.
5. Bidding will be conducted through the Open competitive Bidding procedures as specified in the Procurement Policy and Guidelines of the Asian Development Bank and is open to all eligible bidders as defined in the bidding document.
6. Interested eligible bidders may obtain further information from **Improving the Quality of Health Care Project, Department of Planning and Finance Ministry of Health Lao PDR**, at the address below and inspect the bidding documents during office hours (09:00 to 17:00 hours) at the same address.
7. A complete set of bidding documents in English may be purchased by interested eligible bidders upon the submission of a written application to the address below and upon payment of a nonrefundable fee of **Lot 1: one million Kip** and **Lot 2: one million Kip** by cash payment to the cashier in project office at address below.
8. Upon payment of fee, the document will be made available in hardcopy to be collected by bidder at Project office at the address below. On request from Bidder, the document can be made available as PDF file through email. No liability will be accepted for loss, late delivery, or providing an incorrect email address.
9. Bids must be delivered to the address below on or before **on 26 August 2026 at 14:00 hours**. Electronic submission of bids *will not* be permitted. Bids will be publicly opened in the presence of the bidders designated representatives and anyone who choose to attend at the address below on **26 August 2026** starting at **14:00**. Late bids will be rejected.
