The Lao People's Democratic Republic has received loan from Asian Development Bank (ADB) toward the cost of the Education for Employment Sector Development Project (EESDP) and intends to apply part of this loan for payments under the contract for rehabilitation of school facilities including laboratory, toilet and associated facilities.

2. The Ministry of Education and Sports (MOES) invites sealed bids from eligible bidders for the above civil work package- CW-20:.

4. Bidding will be conducted through the Open Competitive Bidding, Single Stage One Envelope procedures with National Advertising as specified in the ADB Procurement Policy 2017 and is open to all eligible bidders as defined in the bidding document

Interested eligible bidders may obtain further information and inspect the bidding documents on working days during 09:00 am to 16:00 pm on working days at the address given at the end of this invitation. A complete set of the Bidding Documents in English language may be purchased upon submission of a written application to the address below and upon payment of non-refundable fee of

US\$ 100 or equivalent amount in Lao Kip as per the day's bank rate for the contract package. The method of payment shall be in cash or cashier's cheque.

6. Bid must be delivered to the address provided at the address given at the end of this invitation before 02 September 2026 till 1:30 pm, Laos local time. Electronic bidding **will not be permitted**. Late bids will be rejected and returned unopened to the bidders. All bids will be opened at the same date and place of bid receipt at 1:35 pm in the presence of the Bidding Committee, and the bidders' designated representatives and anyone who choose to attend at the address below.

7. All bids must be accompanied by a "Bid-Securing Declaration".
